AT SEA MARRIAGE LICENSE Shipboard Only (12 Nautical Miles at Sea). To ensure licensing documentation is processed in time, 90 days advance booking is required. Additional fees may apply.

We request a minimum of 90-days in order to book a wedding/vow renewal and require the full package price paid upon booking. Wedding/vow renewal dates are on a first come first serve basis, it is recommended that you contact us before booking your cruise to ensure the date you want your event to be on is available. Upgrades to the wedding/vow renewal can be added after booking, and final payment is due 45-days prior to the wedding/vow renewal date.

Please note, prices are subject to change. Couples do have to book their cruise before they can book their wedding/vow renewal.
